ORDER:

In the circumstances reported by the Revenue Ex.II (1) Department in their U.O. 4th read above, the Government after careful examination of the matter hereby makes the following amendments to the Telangana Panchayats Extension to Schedule Areas (PESA) Rules, 2011 issued in the G.O. 1st read above.

2. Accordingly, the following notification shall be published in an extra ordinary issue of the Telangana Gazette Dt:15.10.2019.

NOTIFICATION

In exercise of the powers conferred under section 286 read with sub section 10 of section 6 of The Telangana Panchayat Raj Act, 2018 (Telangana Act No.5 of 2018) and in consonance of the detailed guidelines issued by the Tribal Welfare Department vide G.O.Ms.No.24, Tribal Welfare (LTR.I) Department, Dt. 12.06.2018, the Governor of the Telangana hereby makes the following amendments to the Telangana Panchayats Extension to Schedule Areas (PESA) Rules 2011, issued Vide G.O.Ms.No.66, PR&RD (Mdl.I) Department, Dt. 24.03.2011:-

AMENDMENT

In the said Rules;-

1. In Rule 4 for sub rule (iv), the following shall be substituted, namely:-

(iv) The quorum for the Gramsabha meetings shall be as follows:

i)	Up to 500 voters	-----	50 Members.
ii)	501-1000 voters	-----	75 members
iii)	1001 to 3000 voters	-----	150 members
iv)	3001 to 5000 voters	-----	200 members.
v)	5001 to 10000 voters	-----	300 members
vi)	Above 10000 voters	-----	400 members

"Provided that when the meeting of a Gram Sabha is not held within one hour of the scheduled time for want of quorum, it shall be adjourned. The adjourned meeting shall be held at any time after two hours, and the business at such adjourned meeting may be transacted without the requirement of the requisite quorum."

2. In Rule 8(I) after sub-rule (b), the following Explanation shall be added namely:-

"Explanation":- "The Local Scheduled Tribe Candidate" is as defined in para 2 of G.O.Ms.No.24, Tribal Welfare (LTR.I) Department Dt.12.06.2018.

3. This order shall come into force w.e.f. 01.08.2019.
4. The Commissioner Panchayat Raj & Rural Employment shall take necessary action accordingly.
